# Chapter 13 Accounting for Derivatives and Hedging Transactions (Part 3)

#### **Accounting for futures contract**

Futures contract is a contract traded on an exchange that allows an entity to buy or sell a specified quantity of commodity or a financial security at a specified price on a specified future date.

#### Illustration 1: No hedging designation

On December 1, 20x1, ABC Co. enters into a silver futures contract to purchase 1,000 ounces of silver on February 1, 20x2 for P200 per ounce. The broker requires an initial margin deposit of P20,000. The quoted prices per ounce of silver are as follows:

Dec. 1, 20x1	Dec. 31, 20x1	Feb. 1, 20x2
200	190	185

4 Notes:

- Futures contracts normally require an initial margin deposit with the broker. The initial margin deposit represents a small fraction of the value of the futures contract. This is recorded as "Deposit with futures broker," which is a regular receivable account and not a derivative.
- On the other hand, the broker sets up an account for the entity (investor). This account reflects the subsequent increases or decreases in the fair value of the futures contract. When fair value increases, the entity may be able to withdraw cash from the account. When fair value decreases, the entity may be required to pay additional cash to maintain the specified minimum balance in the account.
- Futures contracts are normally settled on a net cash basis. On settlement date, the initial margin deposit is returned to the entity along with any gain earned on the futures contract. In case of along with any gain earned to the initial margin deposit and any loss, the loss is offset against the initial margin deposit and any remaining amount is returned to the entity.
